Objectives and Investment Policy

Investment Objective:

To provide long term growth through diversification across major asset classes.

Investment Policy:

The Fund will invest in a diversified portfolio of collective investment schemes with exposure predominantly to UK, European and US equity markets with some exposure to Japan, the Far East and emerging markets. The underlying collective investment schemes will invest in principally equity securities and fixed income on a global basis. The asset allocation strategy may be altered by the Investment Manager on a monthly basis or more frequently to take into account changes in the expected risk and correlations of the underlying asset classes.


