The Fund is managed by Davy Global Fund Management Limited (the Manager").

Objectives and Investment Policy

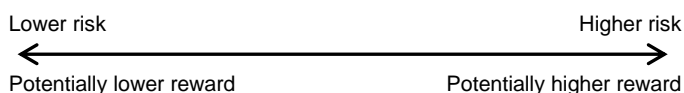
Investment Objective:

The investment objective of the Fund is to provide capital growth while targeting a relatively low level of portfolio volatility of between 70% to 90% of global equity market volatility over rolling three-year periods. The Fund intends to achieve its investment objective by gaining exposure primarily to a globally diversified portfolio of equities, bonds and alternative assets. There can be no assurance that the Fund will achieve its investment objective.

Investment Policy:

The Fund will invest in a diversified portfolio of authorised open-ended UCITS and alternative investment funds ("CIS"). The CIS that the Fund may invest in will be authorised as UCITS or alternative investment funds, consist of regulated collective investment schemes which may be domiciled mainly in Ireland, the United Kingdom and Luxembourg. The underlying investment schemes will invest in principally equity securities and fixed income securities, which may include government and corporate bonds on a global basis.

Other Information:

- The Fund may use FDIs for efficient portfolio management and currency hedging purposes. Such techniques and instruments include options and forwards. The Investment Manager does not expect the use of FDIs to significantly increase the Fund's risk profile.
- You can buy, exchange and sell shares in the Fund on a weekly basis, on the Thursday of each week, or the Business Day immediately following the Thursday if it is not a Business Day in Dublin.
- This class does not intend to pay a dividend. Any income generated by the Fund is reinvested to grow the value of your investment.
- The Fund may not be appropriate for investors who plan to withdraw their money in 2-3 years.

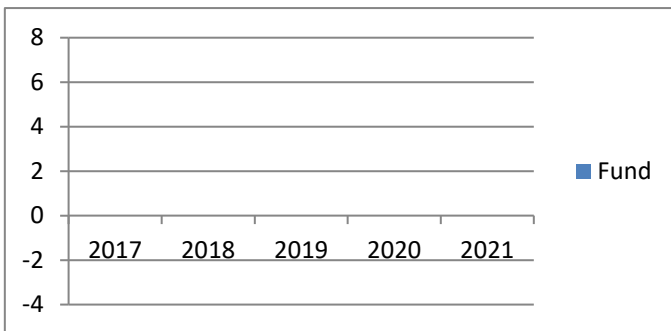
The Directors may impose an anti-dilution levy in the case of net subscriptions and/or net repurchases on a transaction basis as a percentage adjustment on the value of the relevant subscriptions or repurchases to reflect the impact of other dealing costs and to preserve the value of the underlying assets.

There is a repurchase charge of up to 3% of NAV within the first year of issue, up to 2% of NAV within second year and up to 1% of NAV any time thereafter.

The ongoing charges figure shown here are estimated as this fund has less than 1 year of operating history. The ongoing charges figure may vary from year to year, they include the ongoing charges incurred by the underlying CIS and excludes the costs of buying or selling assets for the Fund (unless these assets are shares of another fund).
