Summary of Objective¹

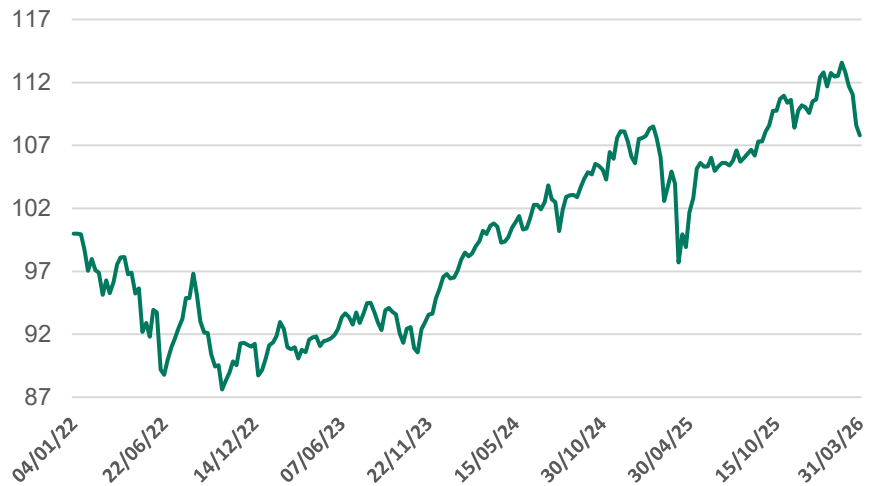
The investment objective of the Fund is to provide capital growth while targeting a moderate level of portfolio volatility of between 50% to 70% of global equity market volatility over rolling three-year periods. The Fund intends to achieve its investment objective by gaining exposure primarily to a globally diversified portfolio of equities, bonds and alternative assets.

Figure 2: Asset Allocation

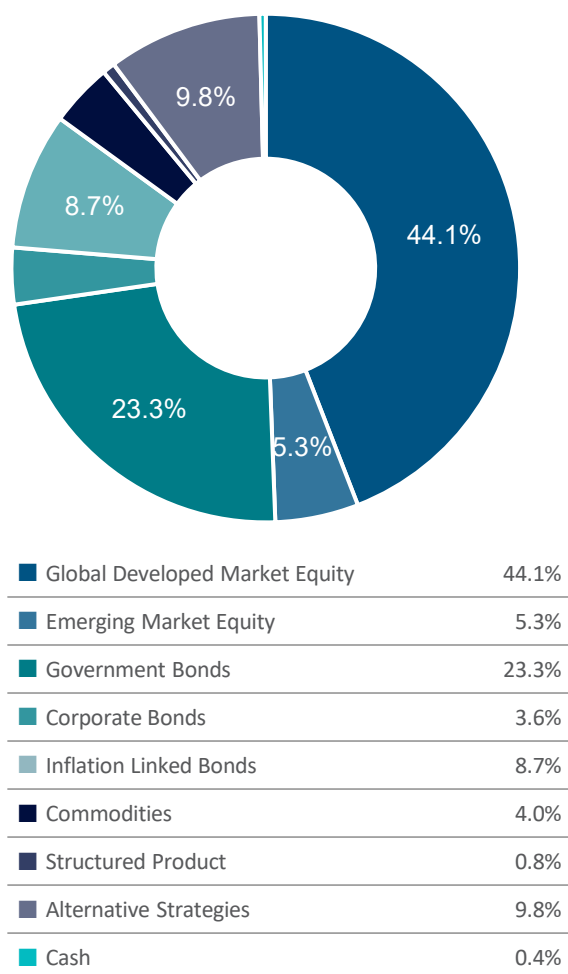
